TAX RELIEF

IMPORTANT notice from Jane L. Irby, Amherst County Commissioner of the Revenue.

This notice is being sent out to all area churches in hopes of reaching many senior citizens in the County, and making them aware of a tax relief program offered by the County of Amherst.

This program is for taxpayers 65 or older, or permanently disabled. This tax break is only given on the home and the homesite not to exceed 1 acre owned and lived in by the taxpayer. The qualifications are as follows:

- The person or persons applying for tax relief must have ownership of the property on or before December 31 of the prior year in which they are applying.
- The owner of the property must be sixty-five or older or disabled on December 31 of the year immediately preceding the taxable year. The dwelling must be occupied as the sole dwelling of the person or persons.
- The gross combined income can not exceed \$50,000. Gross combined income shall include income from all sources of the owner and of the owner's relatives living in the dwelling for which exemption is claimed. The first \$6,500 of each relative living in the home is exempt from total income. This is based on the prior year income.
- The total combined financial worth of the owner as of December 31 of the prior year can not exceed \$150,000. The tax credit is given on the home. Filing date is from January 15 – March 31.
